

## CHAPTER 14

### MISCELLANEOUS PROVISIONS

#### 1400. Flag.

The official flag of Jackson County, Missouri shall be as follows. (Ord. 451, Sec. 1, Eff. 12-2-76)

##### 1400.1 Shape and Field.

The official flag shall be on a rectangular white field having the vertical to the horizontal proportions of two to three. (Ord. 451, Sec. 1, Eff. 12-2-76)

##### 1400.2 Seal.

The official flag shall include the Seal of Jackson County, Missouri having a diameter of two-thirds of the vertical width. (Ord. 451, Sec. 1, Eff. 12-2-76)

##### 1400.3 Other Requirements.

The official flag shall include above the seal the words "Established 1826" and below the seal five (5) five-pointed stars, all of the foregoing in blue. (Ord. 451, Sec. 1, Eff. 12-2-76)

#### 1401. Holidays.

The County Executive shall by executive order establish the dates and number of county holidays so long as the total amount of holidays does not exceed twelve (12) per year. The list of holidays established by executive order shall include a Juneteenth holiday on the nineteenth day of June. (Ord. 551, Sec. 1, Eff. 11/8/77, Ord. 1402, Eff. 12/20/85, Ord. 5513, Eff. 6/7/21, Ord. 5590, Eff. 1/18/22)

### NEIGHBORHOOD WATCH SIGNS

#### 1450. Neighborhood Watch Signs, Who May Request.

The residents of the unincorporated area of Jackson County may request from the Public Works Department permission to erect signs reading "Notice Neighborhood Watch Area Police Will Be Called" in the county road, street or highway right of ways. (Ord. 966, Sec. 1, Eff. 4-27-82)

#### 1451. Form of Request.

The request shall be made by a petition of the residents of any unincorporated area. (Ord. 966, Sec. 1, Eff. 4-27-82)

#### 1452. Contents of Petition.

The petition shall specify the following. (Ord. 966, Sec. 1, Eff. 4-27-82)

1452.1 Number and Location.

The petition shall specify the number and proposed location of the signs. (Ord. 966, Sec. 1, Eff. 4-27-82)

1452.2 Payment of Costs.

The petition shall state that the residents agree to pay all costs for the acquisition, erection and maintenance of the signs. (Ord. 966, Sec. 1, Eff. 4-27-82)

1452.3 Removal of Signs.

The petition shall state that the residents consent to the removal of the signs if the signs are damaged, fall into disrepair or in the opinion of the Public Works Director becomes a traffic or safety hazard. (Ord. 966, Sec. 1, Eff. 4-27-82)

1453. Action on Receipt.

On receipt of the petition, the Public Works Department shall cooperate with the petitioners and with the Jackson County Sheriff's Department to identify proper location and number of signs. (Ord. 966, Sec. 2, Eff. 4-27-82)

1454. When Permission Granted.

If the location of the signs does not pose a traffic hazard, the Public Works Department may grant permission for the erection of the signs. (Ord. 966, Sec. 3, Eff. 4-27-82)

1455. Signs.

All signs must be in compliance with the regulations of the Manual of Uniform Traffic Control Devices and must be approved by the Public Works Department. (Ord. 966, Sec. 3, Eff. 4-27-82)

1456. Costs.

All costs of acquisition, erection and maintenance of the signs shall be borne by the residents requesting the signs. (Ord. 966, Sec. 3, Eff. 4-27-82)

1457. Removal of Sign and Revocation of Permission.

The Public Works Department may remove any neighborhood watch sign if it is damaged, falls into disrepair or becomes a traffic or safety hazard and may revoke the permission to locate any such sign in the right of way. (Ord. 966, Sec. 4, Eff. 4-27-82)
