



Application for Business Personal Property Exemption

In compliance with Missouri Revised Statutes Sections 137.115, 137.122, 137.340, and 140.100, every business, including churches, nonprofits, not-for-profits, etc., operating in Jackson County must renew the Business Declaration Account every year. Failure to open an account and maintain the required annual 'Business Account Declaration' will result in penalties, interest charges, and/or loss of exemption status.

Business Personal Property (BPP) are items owned and utilized for the operation of the organization. This may include the following: office supplies, furniture, fixtures, office equipment, certain machinery, computers, printer/scanner/copier, telephones and cell phones.
