

JACKSON COUNTY, MISSOURI BOARD OF EQUALIZATION

Order Extending Docketed Appeal Hearing Schedule to July 31, 2024
For 2023 Reassessment Cycle Appeals

Whereas, pursuant to the authority granted under Missouri Revised Statutes, sections, 137.385 and 137.275, St. Louis County v. State Tax Commission, 529 S.W. 2d 384 (Mo. S.Ct. 1975) and Lake St. Louis Community Association v. State Tax Commission, 759 S.W.2d 843 (Mo. S.Ct. 1988), good cause has been shown that in order to address the volume of appeals filed in the 2023 reassessment cycle in an orderly manner that affords requisite due process, the previously extended deadline set by statute for scheduling and docketing of hearings on those appeals must be and should be extended to July 31, 2024.

NOW, THEREFORE, IT IS ORDERED THAT:

The deadline for the scheduling and docketing of hearings of appeals arising from the 2023 reassessment cycle to the Jackson County Board of Equalization shall be and hereby is extended to July 31, 2024. The BOE staff and Assessment Department shall take due notice hereof and act in accordance with this Order.


