CHAPTER 53

LOAD LIMITS

SCOPE

5300. Scope.

This chapter sets load limits for through traffic operating on certain county-maintained roadways. (Ord. 692, Title, Eff. 4-21-79)

5301. - 5309. RESERVED

DEFINITIONS

5310. Definitions.

As used in this chapter, the following words have the following meanings.

5311. Bus.

Bus means a motor vehicle designed primarily for the transportation of a driver and eight (8) or more passengers. (Ord. 692, Sec. 1, Eff. 4-21-79)

5312. Gross Weight.

Gross weight means the weight of a vehicle, or a vehicle combination, without a load plus the weight of any load the vehicle. (Ord. 692, Sec. 1.2, Eff. 4-21-79)

5313. Motor Vehicle.

Motor vehicle means any self-propelled vehicle not operated exclusively on tracts. (Ord. 692, Sec. 1.3, Eff. 4-21-79)

5314. Operator.

Operator means a person who operates or drives a motor vehicle. (Ord. 692, Sec. 1.4, Eff. 4-21-79)

5315. Roadway.

Roadway means the improved portion of a county-maintained thoroughfare used for vehicular travel. (Ord. 692, Sec. 1.5, Eff. 4-21-79)

5316. School Bus.

School bus means a motor vehicle used solely to transport students to or from school, or to transport students to or from any place for educational purposes. (Ord. 692, Sec. 1.6, Eff. 4-21-79)

5317. Vehicle.

Vehicle means any mechanical device on wheels designed primary by for use on roadway.

(Ord. 692, Sec. 1.7, Eff. 4-21-79)

OPERATION_OF_MOTOR_VEHICLES

5320. Motor Vehicles Subject to Weight Limits.

Motor vehicles which are operated on roadways are subject to the weight limitations imposed by this or other applicable ordinance for the roadway specified. (Ord. 692, Sec. 2, Eff. 4-21-79)

C/R: 5330.00 - 5332.00, Weight limitations.

5321. Vehicle Operation in Excess of Weight Limits Prohibited.

No motor vehicle shall be operated on any roadway which is subject to weight limitations whose gross weight exceeds the weight for which the vehicle has been licensed by the state. (Ord. 692, Sec. 4, Eff. 4-21-79)

5322. Load Limit Exceptions.

The load limitation imposed by this chapter do not prohibit the following. (O(rd. 692, Sec. 3, Eff. 4-21-79)

5322.1 Necessary to Conduct Business.

The load limitations imposed by this chapter do not prohibit the operation of motor vehicles, otherwise in violation of applicable load limits set by ordinance but not in excess of state load limits, to a destination located on a roadway which is necessary to the conduct of the business of the operator, provided that the roadway in question is used from the intersection nearest the destination point. (Ord. 692, Sec. 3.1, Eff. 4-21-79)

5322.2 <u>Emergency Vehicles</u>.

The load limitations imposed by this chapter do not prohibit the operation of law enforcement of fire fighting equipment or ambulances. (Ord. 692, Sec. 3.2, Eff. 4-21-79)

5322.3 School Bus.

The load limitations imposed by this chapter do not prohibit the operation of school buses. (Ord. 692, Sec. 3.3, Eff. 4-21-79)

C/R: 5316.00, school bus defined.

5322.4 Farm Equipment.

The load limitations imposed by this chapter do not prohibit the operation of farm equipment. (Ord. 692, Sec. 3.3, Eff. 4-21-79)

5322.5 County or Public Utility Vehicles.

The load limitations imposed by this chapter do not prohibit the operation of motor vehicles owned or operated by the county or public utilities or their contractors or material suppliers while engaged in the repair, maintenance or construction of roadways, bridges, right-of-way improvement or utility installations, equipment or fixtures. (Ord. 692, Sec. 3.4, Eff. 4-21-79)

5322.6 Special Permit, Vehicle Load Limitations.

The load limitations imposed by this chapter do not prohibit the operation of motor vehicles, otherwise in violation of applicable load limits, where the operator or owner of the vehicle first secures a permit for that operation from the Department of Public Works. (Ord. 692, Sec. 3.5, Eff. 4-21-79)

C/R: 5350.00 through 5324.00, relating to special permits.

5323. Penalty, Violation of Vehicle Load Limit Code.

The operation of motor vehicles in violation of the applicable load limits imposed by this chapter is a county ordinance violation which shall, on conviction, be punished by a fine calculated at one dollar (\$1) for each pound that the gross weight of the vehicle exceeds the applicable load limit. The fine shall not be less than one hundred (\$100) nor more than one thousand dollars (\$1,000). Ord. 692, Sec. 2, Eff. 4-21-79)

5324. - 5329. RESERVED

WEIGHT LIMITS

5330. Load Limits of Roadways.

All roadways shall carry state load limits if not posted otherwise. (Ord. 692, Sec. 8, Eff. 4-21-79)

5331. 16,000 Pound Limit Roadways.

No motor vehicle or combination of vehicles exceeding a gross weight of 16,000 pounds shall be moved or operated on the roadways listed in Schedule A of this chapter. (Ord. 692, Sec. 8, Eff. 4-21-79)

5332. Load Limits on Bridges.

The load limits imposed by this or any other ordinance for roadways do not apply to or affect the posted load limits established by the Department of Public Works for county bridges. (Ord. 692, Sec. 7.B, Eff. 4-21-79)

5333. <u>Twenty-four Thousand (24,000) Pound Limit Roadways</u>.

No motor vehicle or combination of vehicles exceeding a gross weight of 24,000 pounds shall be moved or operated on the roadways listed in Schedule B of this chapter. (Ord. 1242, Eff. 9-26-84)

5334. - 5339. RESERVED

WEIGHT_CHECKS

5340. Weight Checks.

Any Sheriff's Deputy may request that the weight of a motor vehicle be checked by either of the following means.

5341. Spot Checks.

On the request of any Sheriff's Deputy the operator of a motor vehicle shall permit the vehicle with its load, if any, to be weighed on the spot by the use of load meters or other weighing devices. (Ord. 692, Sec. 5, Eff. 4-21-79)

5342. Scale Check.

On the request of any Sheriff's Deputy the operator of a motor vehicle shall promptly convey the vehicle and load, if any, to the nearest state or public scale so designated by the deputy for the purpose of establishing the gross weight of the motor vehicle. (Ord. 692, Sec. 5, Eff. 4-21-79)

5343. <u>Maximum Weight Exceeded.</u>

If the gross weight established by Sections 5340.00 or 5341.00 is in excess of the maximum weight permitted for the roadway on which the motor vehicle was operated, the Sheriff's Deputy may require that the excess load be unloaded and stored at the operator's expense and risk before the vehicle is allowed to proceed. (Ord. 692, Sec. 5, Eff. 4-21-79)

SPECIAL_PERMITS

5350. Special Permits, Single Indivisible Loads.

Notwithstanding the load limitations imposed by this chapter, the Director of Public Works may, at his discretion, issue a special permit for the carrying of a single, indivisible load in excess of those weight limitations. (Ord. 692, Sec. 6, Eff. 4-21-79)

5351. Contents of Permit.

The special permit issued by the Director shall contain the following.

5351.1 <u>Prescribe Route</u>.

The special permit shall prescribe the route and time of movement as approved by the Director of Public Works. (Ord. 692, Sec. 6, Eff. 4-21-79)

5351.2 Traffic Safety Requirements.

The special permit shall prescribe the traffic safety requirements as approved by the Director of Public Works. (Ord. 692, Sec. 6, Eff. 4-21-79)

5351.3 <u>Insurance Requirements.</u>

The special permit shall prescribe the insurance requirements as approved by the Director of Public Works. (Ord. 692, Sec. 6, Eff. 4-21-79)

5351.4 <u>Precautions</u>.

The special permit shall prescribe precautions to be taken in carrying the load. (Ord. 692, Sec. 6, Eff. 4-21-79)

5352. One Movement.

Special permits shall be for no more than one (1) movement or for a specific period of time. (Ord. 692, Sec. 6, Eff. 4-21-79)

5353. Permits Carried in Vehicle.

Special permits shall be carried in the motor vehicle and on request shall be shown to any Sheriff's Deputy or employee of the Department of Public Works. (Ord. 692, Sec. 6, Eff. 4-21-79)

5354. <u>Liability for Damage</u>.

The beneficiary of the special permit shall be liable to the county for the cost of repair to roadways or other public places damaged by anything done under the special permit or in violation of that permit. (Ord. 692, Sec. 6, Eff. 4-21-79)

5355. Bond, Load Limit Special Permit.

The director of Public Works may, at his discretion, require the applicant with a special permit to furnish a bond to the county conditioned so as to secure to the county the payment if any cost of repairs. (Ord. 692, Sec. 6, Eff. 4-21-79)
