CHAPTER 84

PARKS AND RECREATION ADVISORY COMMISSION

ESTABLISHMENT

8400. Parks and Recreation Advisory Commission Established.

The Jackson County Parks and Recreation Advisory Commission is established in an effort to involve the general public in the planning process for park areas, facilities and services. (Ord. 866, Sec. 1.1, Eff. 3-3-81)

MEMBERS

8410. Number of Members.

The Jackson County Parks and Recreation Advisory Commission shall consist of six (6) members. (Ord. 866, Sec. 1.1, Ord. 1152, Eff. 1-18-84)

8411. Appointment.

The members shall be appointed by the County Executive subject to the power of the County Legislature to disapprove. (Ord. 866, Sec. 1.2, Eff. 3-3-81)

8412. Term.

The term of the members shall be two (2) years. (Ord. 866, Sec. 1.3, Ord. 1152, Eff. 1-18-84)

MEETINGS

8420. Number of Meetings.

The Jackson County Parks and Recreation Advisory Commission shall meet at least one time a year. (Ord. 866, Sec. 2, Eff. 3-3-81)

8421. Public Meetings.

All meetings of the Commission shall be open to the public. (Ord. 866, Sec. 2, Eff. 3-3-81)

DUTIES

8430. <u>Land Use Committee, To be Advised by Parks and Recreation Advisory Commission.</u>

The Commission shall advise the Land Use Committee on general policies of the Department of Parks and Recreation. (Ord. 866, Sec. 3.1, Eff. 3-3-81)

8431. Ascertain Attitudes.

The Commission shall ascertain park and recreation attitudes of individuals and organizations in the county and participate in development of county policy in response to those attitudes. (Ord. 866, Sec. 3.2, Eff. 3-3-81)

8432. Review Plans.

The Commission shall review development plans, projects and programs presented by the Director of Parks and Recreation and make recommendations to the Land Use Committee as to their feasibility and improvement. (Ord. 866, Sec. 3.3, Eff. 3-3-81)

8433. Land Acquisitions.

The Commission shall review and advise the Land Use Committee on proposed land acquisitions, on the acceptance of gifts to the parks system, on the sale of surplus property and on the granting of easements. (Ord. 866, Sec. 3.4, Eff. 3-3-81)

8434. Annual Report.

The Commission shall prepare an annual report evaluating the plans and operations of the Department of Parks and Recreation. (Ord. 866, Sec. 3.5, Eff. 3-3-81)

8435. Perform Studies.

The Commission shall perform studies and other tasks requested by the Land Use Committee of the County Legislature. (Ord. 866, Sec. 3.6, Eff. 3-3-81)
