

NOTICE OF PUBLIC HEARING

Notice is hereby given that Jackson County, Missouri (the “County”) will hold a public hearing in the Legislative Assembly Area, 2nd Floor, at the Jackson County Courthouse at 415 E. 12th Street, in Kansas City, Missouri on September 10, 2026, commencing at 9:00 A.M., regarding a proposed plan of finance, including, the proposed issuance by the County, in one or more series, of taxable or tax-exempt special obligation bonds in an aggregate principal amount not to exceed \$170,000,000 (the “Bonds”).

The Bonds are expected to be issued as Qualified 501(c)(3) Bonds as defined in Section 145 of the Internal Revenue Code of 1986, as amended (the “Code”). Bond proceeds are expected to be used for: (1) the demolition, dismantling, remediation, and clearing of the Professional Services Building of University Health Lakewood Medical Center facilities located at University’s Health’s health care services campus located at 7900 Lee’s Summit Road, Kansas City, Missouri generally bounded by Little Blue Road to the north, Lee’s Summit Road to the east, Rhinehart Road to the west, and East 85th to the south (the “University Health Lee’s Summit Road Campus”); (2) the acquisition, construction, reconstruction, repair, alteration, improvement, extension, furnishing and equipping of facilities and related capital relocation and utility relocation expenses and parking facilities to be used in connection with University Health’s health care operations, including a new dental clinic, a new medical office building and a new support services building each to be located at University Health’s Lee’s Summit Road Campus that will provide office space and space for various services, such as physical therapy, occupational therapy, cardiology, podiatry, dental services, environmental services, and security services; (3) the remodeling and expansion of University Health Lakewood Care Center located at University Health’s Lee’s Summit Road Campus into clinic space; and (4) miscellaneous capital expenditures for the acquisition, construction, reconstruction, repair, alteration, improvement, extension, furnishing, and equipping of health care facilities at the University Health Lee’s Summit Road Campus (collectively, the “Project”). The Project will be owned by the County and operated by Truman Medical Center d/b/a University Health, a tax-exempt organization described in Section 501(c)(3) of the Code. All Bond proceeds are expected to be spent for the above described Project at University Health’s Lee’s Summit Road campus.

The hearing is required by Section 147(f) of the Code and will be open to the public. All interested persons may attend the hearing in the County Executive’s Conference Room and will have an opportunity to express their views with respect to the proposed plan of finance, including, the Project and the issuance of Bonds to finance the Project costs. Following the hearing, the County Legislature will consider whether to approve the proposed plan of finance, including, the Project and issuance of Bonds to finance the Project costs.
